Design and Construction – Project Update Bailey West to Silver Creek Crossing

Brian Kaluzny reported that Cultural Resources at SHIPO have the environmental assessment for an old railroad line in Clarksville.

Erosion Long-term solution - Harrison/Croghan Ave. to Loop Island Wetlands

Bob Polston reported that USACE will be submitting a request for Federal funding in 2016. They are putting together information on land acquisition costs, funding from INDOT and the Lewis and Clark Trail. A draft request should be ready for review by Clarksville in two weeks.

Jeffersonville - Big 4 (INDOT Project)

Kelly Phillips reported that there will be a meeting in the afternoon and they hope to have it open soon.

Jeffersonville -Big 4 Landing (INDOT Project)

Kelly reported that the foot of the stairs area is being completed with sidewalks to go through floodwall to Mulberry; concrete will be poured in May. A lot of the trees have been planted, the water feature has been started, and the light tower has been completed. The pump station on the bridge is also underway. The houses will be relocated in June.

Jeffersonville – Marina (USACE and Jeffersonville)

Kelly reported that the city met with USACE, Jacobi, Toombs and Lantz, DNR and other stake holders regarding what is needed to secure the permit. USACE is making sure they know what the DNR will be requiring. The DNR wants to see more signage about the history of Jeffersonville and the riverfront. The ramp going up to Watt St. is being integrated into the plan by Jacobi, Toombs and Lantz.

Jeffersonville/Clarksville Connector Design

Kelly reported that they are having trouble getting a designation number as this is not yet officially recognized as an INDOT project due to transferring of funding that has not yet occurred.
