Bob Polston reported that they are preparing to submit the USACE report to the Federal government to consider for funding. The city reviewed the report this morning and USACE took full responsibility for the issues.

Kelly Phillips reported that the project is on target to be completed by the first week of October.

### Jeffersonville - Marina (USACE and Jeffersonville)

Kelly reported that they held bid openings last week. All of the bids were higher than the cost estimates so they will be reviewing the scope and will send it out for rebid.

#### Jeffersonville/Clarksville Connector Design

Kelly reported that they are working on trail alignment, lookouts and retaining wall options. They plan to have INDOT review the plan.

A website will also be created devoted to the refresh process.

Phil Hendershot reported that the committee met August 5. He stated that the committee discussed the draft strategic plan. Shaunna reported that she is looking into ways to fund upgraded for the bicycles, i.e. painting, new baskets, etc. Clarksville will be discussing the Monuments and Manuals Policy as presented by ORGC at their next town meeting.

#### **Project Coordinator Report**

Shaunna referenced the written report in the meeting packet. She reported that the grant request she submitted to the New Albany Rotary had not been awarded to us but that they are interested in funding some projects for the Greenway in the future. Shaunna gave a presentation to the Develop New Albany group on August 14.
