One possibility would be the section from the Sherman Minton Bridge to 10<sup>th</sup> St. The committee also discussed possibly securing private funding for this.

### Wayfinding Implementation

Shaunna reported that there still is one sign in New Albany that needs to be moved. The utilities have been cleared for the area and she is working with Geograph to schedule a time for the move. As of Friday of last week, the Jeffersonville/New Albany emergency contact panels have been corrected to each community. She stated that special tools would need to be purchased in order to perform maintenance on these panels in the future. Shaunna reported that she will be distributing a press release with pictures after the New Albany sign is moved and punch list items have been completed.

#### Finance and Funding

Shaunna reported that the Finance and Funding committee met November 6th and discussion focused primarily on the proposed 2016 Operating and Capital Budgets. She distributed copies of the proposed budgets to Commission members and provided and overview of the proposed changes as well as the accompanying back up documents. She asked that members make any suggestions prior to the December Steering or Finance and Funding committee meetings.

#### **Steering Committee**

Phil reported that the committee met November 4<sup>th</sup>. The committee discussed the 2016 operation and capital budgets as well as the strategic planning session. They talked about who might be invited to lead and/or facilitate the strategic planning session. Shaunna reported that, as a member of CNPE, the Commission is eligible for 90 minutes of free consultation from CNPE staff and has access to facilitators. She stated that, as part of the free consultation, CNPE staff will be invited to the January Steering Committee meeting.

# Community Outreach/Friends of the Greenway

Meredith reported that the ORGC/Friends Group Meet and Greet was held Thursday, November 5 at Flat12 Bierwerks. Tour de Pork volunteers were on hand to present a check in the amount of \$5,000, from the proceeds of the 2015 Tour de Pork, to the Friends of the Ohio River Greenway. Meredith reported Kent Lanum and Vern Eswine gave a Greenway 2040 presentation during the Friends' Group November Director's meeting.

## **Project Director Report**

Shaunna referenced her report in the meeting packet. She distributed new Humana Grant process information. She, Phil and Nick Creevy, FOG Director, will be working together to put together a Letter of Intent (LOI) to submit via the Friends of the Ohio River Greenway.

Shaunna distributed the Community Foundation's Needs Assessment regarding improving the health of communities in Southern Indiana. Information from this could be used as part of the LOI health information. She stated that she has spoken with Kelly Hoffmann to see if she can get a report outlining the number of visitors coming into Southern Indiana via the Big 4 Bridge.

Shaunna distributed a draft copy of the 2015 ORG Commission meeting attendance record to date and asked that members review for accuracy.

Shaunna presented to the Georgetown Kiwanis club about the Greenway on November 17.
